

RIDDLE ME THIS, LLC PRIVACY POLICY

Last Updated: June, 2019

This privacy policy (“Policy”) applies to the Web site owned and operated by Riddle Me This, LLC (“Company”) located at www.riddlemethisrva.com (the “Site”). The Policy describes how we collect and use personal information so you can make an informed decision about using our Site. Please read this statement before using our Site or submitting any personal information to us. By using our Site, you represent that you are 13 years old or older and you consent to the information collection and practices described herein. To use the Site you must agree to this Policy and our Terms of Use.

Information Collection

As used herein “personal information” generally means information that specifically identifies an individual (such as name, address, telephone number, email address, credit card or other account number) or that is associated with an identifiable person. Personal information does not include, and this policy does not cover, any publicly available information and public records about professionals, including without limitation information obtained from licensing authorities, associations, accrediting bodies, courts, law enforcement agencies, and websites that are available to the public. This privacy policy in no way limits or restricts our collection of aggregate information or of non-personal information.

Personal information may be collected from you in a number of ways. If you register with the site we may collect your name, address, phone number, email address, and other personal, professional, demographic and business information you provide. In addition, from time to time, we may collect demographic, contact or other personal or demographic information you provide in connection with your participation in surveys, promotional offers, forums and other interactive areas of the Site.

We may log information using “cookies.” Cookies are small data files stored on your harddrive by a website. Cookies help make our site and your visit better. Cookies are used to see which part of our Site people like and use, and to count visits to our Site. We may log information using digital images called Web beacons. Web beacons are used along with cookies to compile aggregated statistics to analyze how our Site is used and may be used to tell is you open or act on our emails. This allows us to gauge the effectiveness of our communications and learn what marketing works and what does not.

Usage of Information

Company may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the service you need and request. At times, we may find it necessary to use contact information with the intention of informing you of other possible products and/or service that may

be available to you from www.riddlemethisrva.com. Company may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or possible new service that are offered or may be offered. Company does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Company may deem it necessary to follow websites and/or page`s that their users may frequent in an effort to glean what types of services and/or products may be the most popular to customers or the general public.

Company may disclose your personal information, without prior notice to you, only if required to do so pursuant to applicable laws and/or in a good faith belief that such action is deemed necessary or required to:

Conform to decrees, laws and/or statues or in an effort to comply with any process which may be served upon Company and/or its website.

Safeguard and/or preserve all the rights and/or property of Company, and perform under demanding conditions in an effort to safeguard the personal safety of users of www.riddlemethisrva.com and/or the general public.

We use personal information we collect from you to operate, maintain, and improve our Site, products and services. The personal information will be used to process your transactions or requests, provide you with information, products or services, and assist us with the operation of the Site and of our business.

Links to Other Website

Our Site may contain links to other websites, or interactive forums hosted by third parties. Please be aware that linking to another website or presenting a banner advertisement is not an endorsement, authorization or representation of our affiliation with that third party, nor is it an endorsement of their privacy or information security practices. We encourage you to be aware when you leave our Site and to read the privacy policies of any Web site that collects personally identifiable information. Other websites follow different rules regarding the use or disclosure of personal information you submit to them.

Security

Company is very concerned with safeguarding your information. When you enter sensitive information (such as a credit card number) on our registration or other forms, we encrypt that information. No method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore we cannot guarantee its absolute security.

Opting Out of Cookies

Control Over Your Information

We may automatically enroll you in one or more email subscription plans.
